Guidelines for Submission:

Authors and reviewers are requested to follow the following guidelines while preparing or reviewing the manuscripts.

1. All manuscripts must be within the 4000-6000 words including footnotes. No manuscripts would be considered for publication if it exceeds the suggested word limit.
2. Submissions should be sent directly to the Acting Editor-in-Chief at jscjkkniu@gmail.com and a hard copy by post or courier service. Hardcopy of the manuscript should be submitted with single sided print.
3. A 150-word abstract should appear at the beginning of the document.
4. A 40 -word biography about the author (s) should also be included.
5. **The journal engages in double-blind peer reviews;** authors' names must be excluded from the text.
6. Manuscripts should be 1.5 spaced with Times New Roman, 12-point type and 1 inch margins, including footnotes.
7. In case of joint ownership, there shall not be more than three authors.
8. Manuscripts submitted to the **Journal of Social Science** should not have been published previously. Authors found submitting the manuscripts in several journals at a time will be black-listed forever.
9. The articles published in the **Journal of Social Science** do not represent the views of the editorial board. The Editor is responsible for the final selection of content and reserves the right not to publish work deemed inappropriate for publication.
10. Responsibility for the views expressed in published work lies solely with the individual authors.
11. Manuscript should be submitted only in English.
12. The journal only accepts the footnotes. Endnotes are not accepted. All footnotes must be formatted according to the following style;

- **Electronic Book (eBook):** If available in print and electronic format, cite as print format. If available only in electronic format, use the Internet materials format: 8Peter Barton Hutt (ed), Food and Drug Law: An Electronic Book of Student Papers (1 April 2008) Harvard Law School.
- **Journal Article:** Andrew Maynes, 'Personal Property Securities Wake-up Call' (2009) 83(4) Law Institute Journal 34, 36.
- **Newspaper Articles:** Andrew Ashworth, 'Jury Told to Weigh Morality of Patel', The Sun (Sydney), 23 June 2010, 11.

- **Short Quotations: In the body of the text and in the footnotes, short quotations (of three lines or less) should be incorporated** within single quotation marks.
Example: Adrian J Bradbook stated that 'England's plastic bag usage drops 85% since 5p charge introduced'.
- **Long Quotations (of more than three full lines) should appear** indented from the left margin, in a smaller font size, and without quotation marks.
